# Air Suction Filter Safety Instructions



**Warning** indicates a hazard with a medium level of risk which, if not avoided, could result in death or serious injury.

### Warning

  - **\*2)** Vacuum pads are excluded from this 1 year warranty.

A vacuum pad is a consumable part, so it is warranted for a year after it is delivered. Also, even within the warranty period, the wear of a product due to the use of the vacuum pad or failure due to the deterioration of rubber material are not covered by the limited warranty.

If handled improperly, compressed air can be dangerous.


The assembly, handling, repair, and element replacement of pneumatic systems should be performed by a knowledgeable and experienced person.

## 2. Removal of equipment and supply/exhaust of compressed air

When components are removed, first confirm that measures are in place to prevent workpieces from dropping, run-away equipment, etc. Then, cut off the supply pressure and electric power, and exhaust all compressed air from the system using the residual pressure release function. When the equipment is operated after remounting or replacement, confirm that the equipment is operating normally.



## A Warning

3. The performance of an ejector will deteriorate due to clogged suction filters and silencers.

High flow filters should be used, especially in dusty locations.



If a filter is required on the release pressure side, a different filter should be prepared.

4. When the element becomes clogged, stop operation and adjust the internal pressure of the filter to atmospheric pressure before replacing the element.

## A Caution

- 1. When the element comes to the end of its life, immediately replace it with a new filter or replacement element.
- **2. Timing of element replacement** Element should be replaced in either of the two cases below.
  - 1) After 1 year of usage has elapsed.
  - When the pressure drop reaches 20 kPa even though the operating period has been less than 1 year.
- 3. During disassembly and assembly, confirm that there are no scratches, damage, etc, to the gasket.
- 4. Before using, confirm there is no leakage after replacing elements.



### 3. Mounting

- 1) Piping
  - Flush the piping before connecting the piping
  - Confirm the IN and the OUT before piping. The product should not be used with the wrong connection. (IN and OUT direction should be identified by the IN mark indicated on the case.)
  - Tighten the product to the recommended torque.
  - Confirm that chips from the pipe threads and sealing material do not enter the piping. Also, when sealant tape is used, leave 1.5 to 2 thread ridges exposed at the end of the threads.

Note) Confirm that there is enough space for maintenance before installing and piping this product.

- 2) Operation
  - Flush the piping line before the starting actual operation when the filter is used for the first time or has been replaced.

### 4. Element Replacement

The replacement time for elements is when one of the following conditions occurs.

- 1) After 1 year of usage has elapsed.
- 2) When the pressure drop reaches 20 kPa even though the operating period has been less than 1 year.



<Element Replacement >

- 1. Stop operation and reduce the filter's internal pressure to atmosphere.
- 2. Loosen the stop pin and open the cover.
- 3. Hold the knob on the top of the element and take it out.
- 4. Check the gasket for damage, deformation, or swelling. If any fault is found, replace the gasket with a new one.
- 5. Replace the element with a new one in the reverse order.
  - Note that the cover cannot be closed if the element is inserted into the case in incorrect orientation.
- 6. Close the cover and tighten the stop pin firmly. [Tightening torque: 1.2N · m +/-10%]
- 7. After checking that no leakage is found from each part, start the actual operation.
